- 7) 22 Hanover Ave Renovation of a single-family townhouse, with new stair and headhouse and an additional two floors over the lower portion of the existing building.
 - Unanimous In-Favor vote
 - Seeking Zoning relief for yard and roof

- 8) 128-134 North Street- Proposal to change occupancy of the to a single-family dwelling on a newly established 3,102 s.f. lot.
 - Strategic Partnership with NEMPAC as 501c3 organization
 - No changes to exterior of building
 - Jeff Drago architect, Eddie Gaffney architect, Mary Lupoli daughter of owner, Sal Lupoli owner all spoke on behave of project
 - Biggest concern is the building shares all walls with North Bennet school. Concerned about impact on piano tuning especially- Sarah Turner the president of North Bennet school asked for advocacy and support and a formal construction management plan
 - Open dialogue with owners and school
 - Already approved by Mass DOT and Mass Architecture Society
 - Tabled vote to October meeting (NEWRA did the same) to follow up on formal plans with Bennet School
